



VOLUNTEER COMPLIANCE AGREEMENT, GUIDELINES & STATEMENT OF FAITH

Volunteer Compliance Agreement:

- I understand that I am a volunteer worker and not an employee of the Raleigh Dream Center.
- I am aware of the hazards and risks to me and my property associated with serving in a missions capacity and I voluntarily assume all these risks, including the possibility of destruction or stealing of personal property, illness or death, and release Raleigh Dream Center from any liability that me or my family may suffer as a result of participation in their mission outreaches and programs. I further recognize that such risks have always been associated with missionary service. (2 Corinthians 11:23-28)
- I expressly agree that this assumption of risk agreement is intended to be as broad and inclusive as permitted by law. I further state that I HAVE CAREFULLY READ THE FOREGOING ASSUMPTION OF RISK AND UNDERSTAND ITS CONTENTS, AND I VOLUNTARILY AGREE TO THIS RELEASE AS MY OWN FREE ACT.
- I authorize that pictures or video of me or my family members while volunteering might be used for RDC's promotional purposes (social media posts, website, email newsletters, etc.)
- I will use my best efforts to ensure that I and my family or group's conduct complies with the guidelines below:

Guidelines: I will commit to following the guidelines below as I volunteer in Raleigh Dream Center's outreaches.

- Never walk alone.
- Always smile and be ready to listen and love.
- Ask if people would like prayer and be prepared to share the gospel.
- Do not give cash to those we are serving.
- Avoid giving out your cell phone number to anyone.
- Out of respect, do not photograph, video or post the people you are serving unless specific permission is given.
- Please do not use foul or abusive language.
- Try not to have valuable items with you.
- Do not give any legal or medical advice.
- Do not make any guarantees or promises on the behalf of Raleigh Dream Center or yourself.



- A volunteer may not use, possess, distribute, sell or be under the influence of alcohol or illegal drugs. The legal use of prescription medicine is permitted only if it does not impair a volunteer’s ability to perform the essential functions of the volunteer position.
- A volunteer may not bring anything considered to be a weapon with them.
- If children are serving alongside you, they are the responsibility of the parent/guardian or group leader.

Statement of Faith: Raleigh Dream Center is a Christian Ministry and I am in agreement with Raleigh Dream Center’s Statement of Faith below:

- We believe in the Holy Scriptures as originally given by God, divinely inspired, infallible, entirely trustworthy; and the supreme authority in all matters of faith and conduct.
- We believe in one God, eternally existent in three persons, Father, Son, and Holy Spirit.
- We believe in our Lord Jesus Christ, God manifested in the flesh, His virgin birth, His sinless human life, His divine miracles, His vicarious and atoning death, His bodily resurrection, His ascension, His mediatorial work, and His Personal return in power and glory.
- We believe in the Salvation of lost and sinful mankind through the shed blood of the Lord Jesus Christ by faith apart from works.
- We believe in the Holy Spirit, by whose indwelling the believer is enabled to live a holy life, to witness and work for the Lord Jesus Christ.
- We believe in the Unity of the Spirit of all true believers, the Church, the Body of Christ.
- We believe in the Resurrection of both the saved and the lost; they that are saved unto the resurrection of life, they that are lost unto the resurrection of damnation.
